## Huawei Inverter - DC Switch disconnector compliance

The PCE integrated switch disconnectors for below listed Huawei inverter models are certified to IEC 60947.1:2015, AS 60947.3:2018, and able to comply with the PCE enclosed DC switch disconnector requirements of AS/NZS5033:2014 Amd1 & Amd2. The switch Disconnectors are DC-PV2 utilization category, where I (make) and Ic (break) is 4 times Ie (rated operational current). In line with AS/NZS 5033 amd 1's Clause 4.4.1.2 (c) where the switch disconnector is enclosed in the PCE, and being in the off position, considering it is removed as a whole for replacement (i.e. cover never removed), there is no risk of electrical hazard.

The switch disconnectors comply with amd 2 clause 4.3.5.2 (a,c,d,e,f,g,h,i,j/iv/A,k). The le and Ic are rated such that the disconnector is capable of interrupting the maximum rated PV array normal and fault current as specified in the inverter manuals and instructions. The PCE integrated DC switch disconnectors are from SANTON (model XBHP+), and are compliant with EESS/ERAC requirements for Level 3 equipment.

The third, fourth and fifth digits in the Serial Number means the period of production, showing here that this particular inverter was manufactured in Aug in 2019

If the fifth digit is A, it means manufacturing month is Oct. Similarly, B refers to Nov, and C refers to Dec. For the 29.9kTL, 36kTL, and 50kTL M0, if the period digits in S/N are greater or equal to 19A, this declaration is valid for that unit.
